To address the portion of your email about CATEX versus EA, this is not a piece of a larger action that we are trying to apply multiple CATEXs to, which is what your 5090 quote refers to. We are planning a more programmatic look at SPECWAR

training in the NW as they are wanting to increase their training activities within our AOR. The broader look does indeed require an EA, as it will cover multiple training activities at various sites for a certain period of time, along with associated consultations.

This CATEX and the one we did in 2015 are covering a discrete training exercise evolution, with limited locations and activities, with a defined start and end date to allow some level of NEPA coverage for these activities in the short term until we can complete the larger scale EA. This is a common approach to operational NEPA projects for evolving training and/or testing activities. This approach has been run by our various legal counsels, and has been briefed through up to the Admiral as our recommended NEPA approach.
